

Features


- Output current in excess of 0.5A

Description

The LM317M is a 3-terminal adjustable positive voltage regulator capable of supplying in excess of 500mA over an output voltage range of 1.2V to 37V. This voltage regulator is exceptionally easy to use and requires only two external resistors to set the output voltage.




Figure 1. Minimum Load Current




Figure 2. Peak Output Current vs. Input-Output Differential Voltage




Figure 3. Adjustment Pin Current vs. Temperature




Figure 4. Ripple Rejection vs. Frequency




Figure 5. Load Regulation vs. Temperature




Figure 6. Line Regulation vs. Temperature




Figure 7. Outputvoltage vs. Temperature




Figure 8. Thermal Shutdown




Figure 1. 1.5V Electronic Shutdown Regulator

D1 protects the device during an input short circuit.





Figure 2. Slow Turn-On Regulator




