



Figure 1. Test circuit for $V_{(BR)CEO}$

(1) Fast electronic switch





Figure 2. Test circuit for switching characteristics – resistive load

(2) Fast recovery rectifier







Figure 3. Test circuit for switching characteristics – inductive load



Figure 4. I_C vs. V_{CE} 



Figure 7. h_{FE} vs. I_C 




Figure 8. t_s vs. $-I_{B2}/I_{B1}$

Figure 6. V_{CEsat} vs. I_B 



Figure 9. t_f vs. $-I_{B2}/I_{B1}$





It is the policy of **Vishay Semiconductor GmbH** to

1. Meet all present and future national and international statutory requirements.

3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
