# Silicon Photodetector with Logic Output

### **Description**

TESS5400 INLINE is a high sensitive Photo Schmitt Trigger in a sideview plastic package with spherical lens.


Its epoxy casting is designed as an infrared filter spectrally matched to GaAs IR emitters ( $\lambda_p$ =950nm).




Figure 1. Test circuit






Figure 2. Pulse diagram

#### **Ozone Depleting Substances Policy Statement**
