

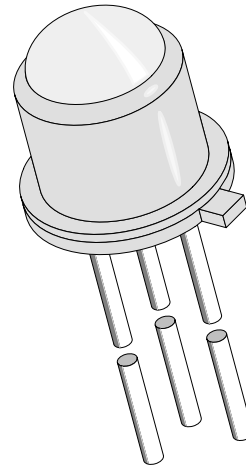
Silicon NPN Phototransistor

Description

BPW77N is a very high sensitive silicon NPN epitaxial planar phototransistor in a standard TO-18 hermetically sealed metal case.

Its glass lens featuring a viewing angle of $\pm 10^\circ$ makes it insensitive to ambient straylight.

A base terminal is available to enable biasing and sensitivity control.

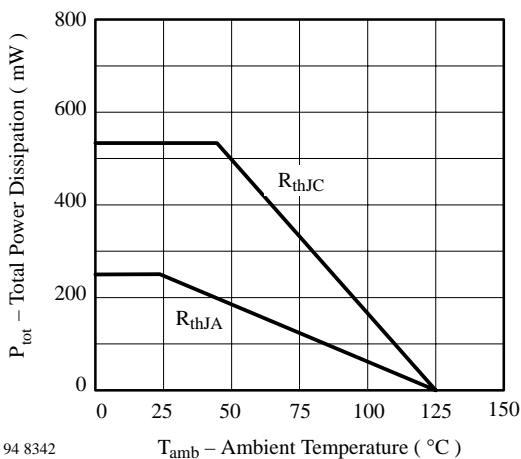


Figure 1. Total Power Dissipation vs. Ambient Temperature

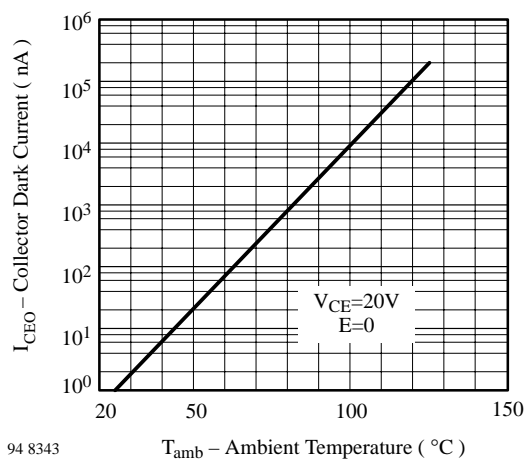
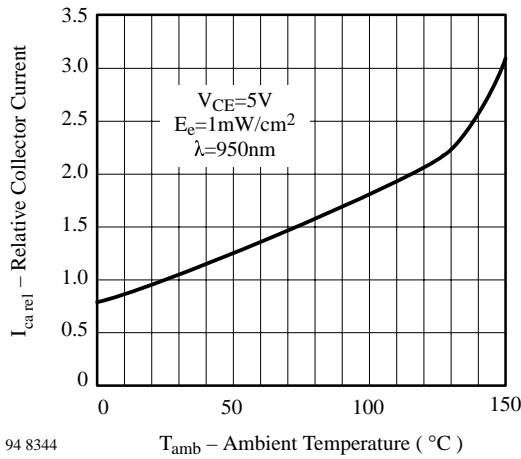
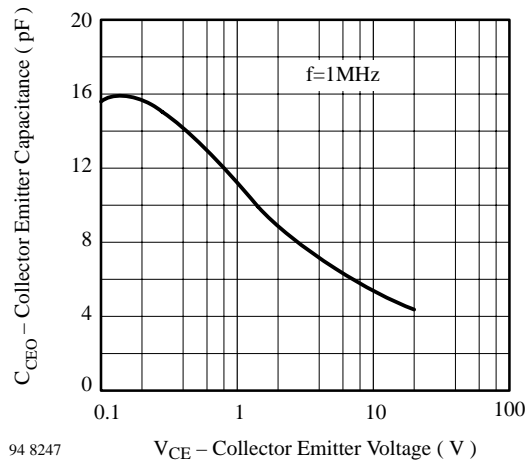


Figure 2. Collector Dark Current vs. Ambient Temperature



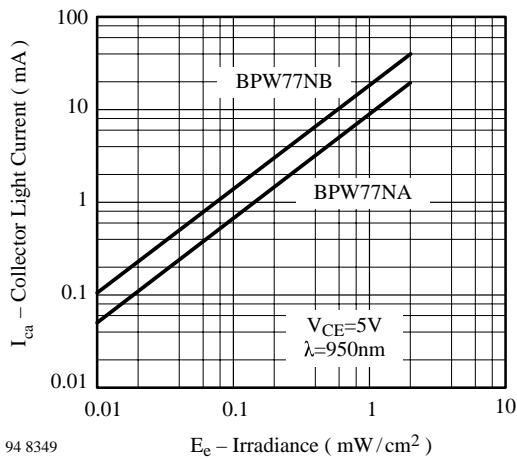

Figure 3. Relative Collector Current vs. Ambient Temperature



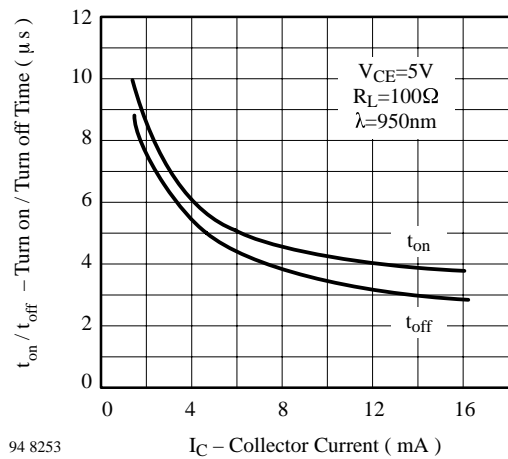
94 8247 V_{CE} – Collector Emitter Voltage (V)

Figure 6. Collector Emitter Capacitance vs. Collector Emitter Voltage



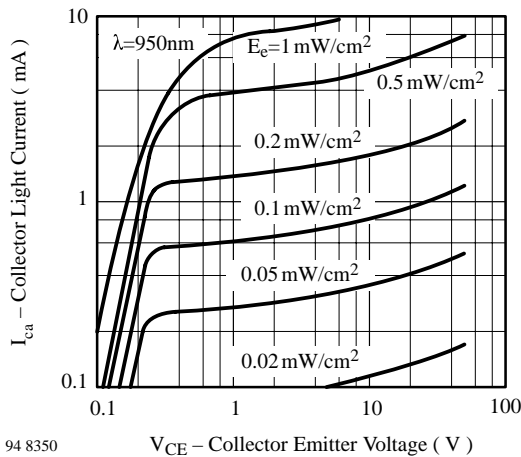
94 8349 E_e – Irradiance (mW/cm²)

Figure 4. Collector Light Current vs. Irradiance



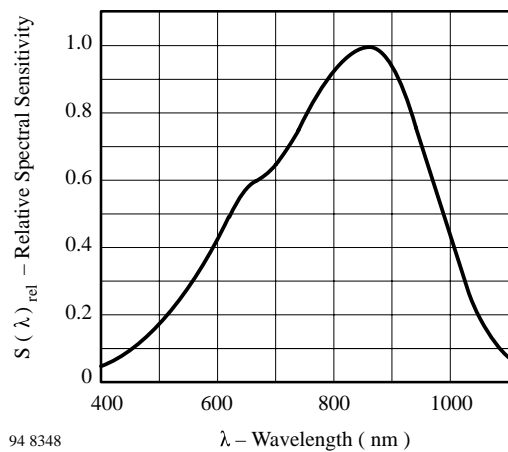
94 8253 I_C – Collector Current (mA)

Figure 7. Turn On/Turn Off Time vs. Collector Current



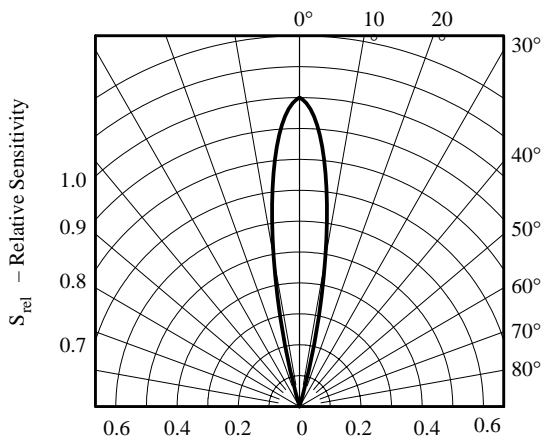
94 8350 V_{CE} – Collector Emitter Voltage (V)

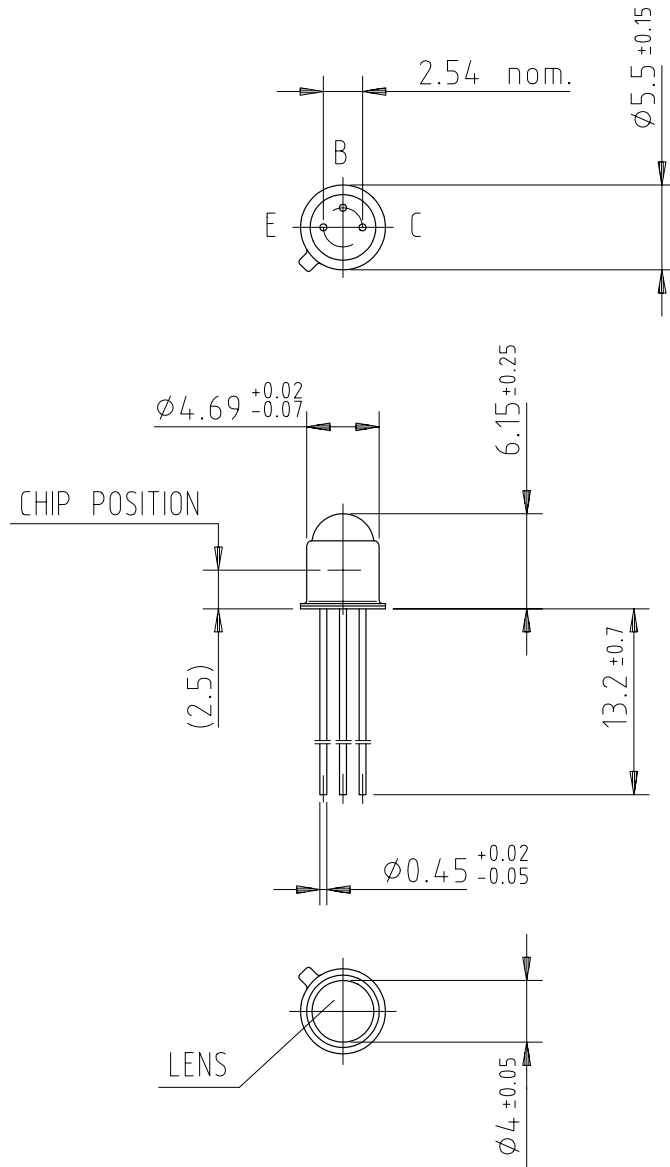
Figure 8. Relative Spectral Sensitivity vs. Wavelength



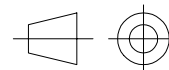

It is the policy of **Vishay Semiconductor GmbH** to

1. Meet all present and future national and international statutory requirements.
