


# GaAs Infrared Emitting Diode in Side View Package

## Description

CQX48 is a standard GaAs infrared emitting diode in a flat sideview plastic package.

A small recessed spherical lens provides an improved radiant intensity in a low profile case.

The diode is case compatible to the BPW78 photo-transistor, allowing the user to assemble his own optical interrupters.




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature




Figure 3. Forward Current vs. Forward Voltage




Figure 6. Radiant Power vs. Forward Current




Figure 4. Relative Forward Voltage vs. Ambient Temperature




Figure 7. Rel. Radiant Intensity/Power vs. Ambient Temperature




Figure 5. Radiant Intensity vs. Forward Current






Figure 8. Relative Radiant Power vs. Wavelength

## Ozone Depleting Substances Policy Statement
