


Figure 1. Input Characteristics




Figure 3. Transistor Output Current vs. Voltage




Figure 2. Transistor Current vs. Voltage




Figure 4. I_{CEO} at V_{CE} = 10 V vs. Temperature




Figure 5. Normalized CTR vs. Forward Current




Figure 8. t_{fall} vs. Forward Current




Figure 6. t_r vs. Forward Current




Figure 9. t_{on} vs. Forward Current




Figure 7. Saturated Switching Characteristics Measurements-Schematic and Waveform




Figure 10. $t_{\rm off}$ vs. Forward Current






Figure 11. t_{phl} vs. Forward Current






Figure 12. t_{plh} vs. Forward Current


