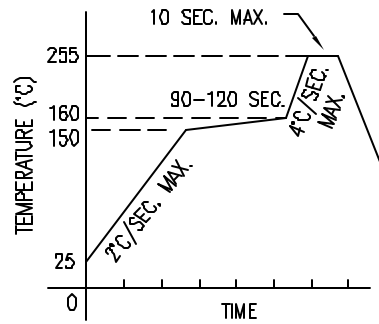

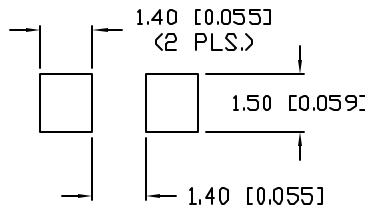


LEAD FREE REFLOW PROFILE
