The TC7MB3257 is high-speed CMOS quad 1-2 multiplexer/demultiplexer. The low on resistance of the switch allows connections to be made with minimal propagation delay time.


This device consists of four individual two-inputs multiplexer/demultiplexer with common select input (S) and output enable ($\overline{\text{OE}}$). The A inputs is connected to the B1 or B2 outputs determined by the combination both the select input (S) and output enable ($\overline{\text{OE}}$). When the output enable ($\overline{\text{OE}}$) input is held "H" level, the switches are open with regardless the state of select inputs and a high-impedance state exists between the switches.


All inputs are equipped with protection circuits against static discharge.

Pin Assignment (top view)









AC Waveform




Figure 2 t_{pLH} , t_{pHL}






Figure 3 $t_{pLZ}, t_{pHZ}, t_{pZL}, t_{pZH}$


