LIMITED WARRANTY

INTRODUCTION

Thank you for your purchase of the MX44 MINI-MIX IV. This unit is a four channel active mixer for mixing instrument or line level unbalanced signals.

DESCRIPTION

OUTPUT: 1/4" Tip-Ring-Sleeve jack for connection to a mixer input, amplifier or other input device. *NOTE: This output will drive a pair of headphones.*

9V BATTERY: Compartment for a 9 Volt alkaline (preferred) battery.



9-16 VDC: Power jack located on the side panel, for connection to an optional PS27 12 volt DC power supply.

PWR LED: Indicates that power is applied to the MX44. If using battery power, this LED lights when a plug is connected to the Output jack.

VOLUME 1 - 4: Control the level of the signals coming from Inputs 1 - 4.

IN 1 - 4: 1/4" unbalanced jacks for connection to line or instrument level devices.
