




Figure 1. Max. Thermal Resistance vs. Lead Length




Figure 3. Forward Current vs. Forward Voltage




Figure 2. Junction Temperature vs. Reverse/Repetitive Peak Reverse Voltage




Figure 4. Typ. Diode Capacitance vs. Reverse Voltage






Figure 5. Thermal Response




Figure 6. Thermal Response




Figure 7. Thermal Response







Figure 8. Thermal Response
