
### 使用上の注意


ショットキーバリアダイオードは他のダイオードと比べ、逆方向の漏れ電流が大きく周囲温度の上昇に伴い、ダイオードの逆方向損失が増加し、それによって更に製品の内部温度が上昇し、ついには熱破壊(熱暴走)に至る恐れがあります。そのため、本製品をご使用の際は周囲温度と逆方向損失を十分に考慮し、熱的設計及び安全設計を行ってください。
