Description

Fiberxon FTM-9301S-S20iG/FTM-9501S-S20iG is high performance, cost effective transceiver. It is designed point-point FTTX applications at data rates of 155Mbps for 20km transmission.

FTM-9301S-S20iG is normally used in the client (ONU), which transmits 1310nm and receives 1550nm optical signal; while FTM-9501S-S20iG is used in the central office (OLT), which transmits 1550nm and receives 1310nm optical signal.

FTM-9301S-S20iG/FTM-9501S-S20iG features an EEPROM that contains the detailed product information stored for retrieval by host equipment. This information is accessed via the 2-wire serial CMOS EEPROM protocol. For further information, please refer to SFP Multi-Source Agreement (MSA).

EEPROM Information

The SFP MSA defines a 256-byte memory map in EEPROM describing the transceiver's capabilities, standard interfaces, manufacturer, and other information, which is accessible over a 2 wire serial interface at the 8-bit address 1010000X (A0h). The memory contents refer to Table 6.






Figure 2, Recommended Interface Circuit

Figure 2 shows the recommended interface circuit.



Notes:

 TX Fault is an open collector output, which should be pulled up with a 4.7k~10kΩ resistor on the host board to a voltage between 2.0V and Vcc+0.3V. Logic 0 indicates normal operation; logic 1 indicates a laser fault of some kind. In the low state, the output will be pulled to less than 0.8V.

2. TX Disable is an input that is used to shut down the transmitter optical output. It is pulled up within the module with a $4.7k\sim10k\Omega$ resistor. Its states are:




Low (0~0.8V):	Transmitter on
(>0.8V, <2.0V):	Undefined
High (2.0~3.465V):	Transmitter Disabled
Open:	Transmitter Disabled

- MOD-DEF 0,1,2 are the module definition pins. They should be pulled up with a 4.7k~10kΩ resistor on the host board. The pull-up voltage shall be VccT or VccR.
 MOD-DEF 0 is grounded by the module to indicate that the module is present
 MOD-DEF 1 is the clock line of two wire serial interface for serial ID
 MOD-DEF 2 is the data line of two wire serial interface for serial ID
- LOS is an open collector output, which should be pulled up with a 4.7k~10kΩ resistor on the host board to a voltage between 2.0V and Vcc+0.3V. Logic 0 indicates normal operation; logic 1 indicates loss of signal. In the low state, the output will be pulled to less than 0.8V.
- 5. These are the differential receiver outputs. They are AC-coupled 100Ω differential lines which should be terminated with 100Ω (differential) at the user SERDES.

These are the differential transmitter inputs. They are AC-coupled, differential lines with 100Ω differential termination inside the module.





Figure 4, Product Mechanical Design Diagram

The mechanical design diagram is shown in Figure 4.
