





# Conversion Efficiency






#### External components setting

FUSE: Fuse Please make sure to use quick acting fuse 1A

C1: Capacitor for input voltage smoothing

Capacitance: 22µF~820µF Rated voltage: 400V or higher Ripple current is 0.13Arms above.

C2: For noise terminal voltage reduction Capacitance:  $0.1\mu$ F $\sim$ 0.22 $\mu$ F Rated voltage: 400V or higher Film capacitor or ceramic capacitor. Reduce the noise terminal voltage.


